

Recruitment of Full Fee Paying Overseas Students Policy

Kambala's Policy

It is the School's policy to ensure that, prior to accepting full fee paying overseas students for enrolment, the School provides comprehensive, current and plain English information to the full fee paying overseas student or intending full fee paying overseas student on all matters required of the School by National Code Standard 2.1.

Younger Full Fee Paying Overseas Students

Younger full fee paying overseas students are students who are under the age of 18.

As part of the School's commitment to keeping our full fee paying overseas students safe, the School has implemented policies and procedures to ensure our full fee paying overseas students, and in particular, our younger full fee paying overseas students, remain safe.

Cancellation and Refunds

Standard 2.1 of the National Code requires the School to have documented cancellation and refunds policies available for our full fee paying overseas students or intending full fee paying overseas students.

English Language Proficiency and Educational Qualifications

Standard 2.2 of the National Code requires the School to have a documented policy and process for assessing whether a full fee paying overseas student's English language proficiency and educational qualifications are sufficient to enable them to enter the course.

It is the School's policy that we do not assess or recognise prior learning of an full fee paying overseas student for the purposes of enrolment in a course at the School.
